The Competent Person Training Seminar covers the CAL-OSHA Title 8, Section 1540 through 1541.1 requirements pertaining to excavations, trenching and sloping techniques, protective systems and soils classification and an introduction to confined space entry safety. The length of the course is approximately 7-1/2 hours with a written 50 question test at the end of class.
